- March 16 Nominations accepted from the floor and close at this AR meeting. Candidates may make oral statements at this time and/or answer questions.
- March 16 Candidate statements deadline. Candidate statements can be no more than 100 words. (No exceptions)
- March 20 Voting opens on the CCEA web site. (cceanow.org)
- April 10 Campaigning ceases.
- March 20 – April 10 CCEA Election **(ALL VOTING MUST BE COMPLETED ON THE CCEA WEB SITE BY 5:00 P.M. TO BE COUNTED ON APRIL 10. NO EXCEPTIONS!)**

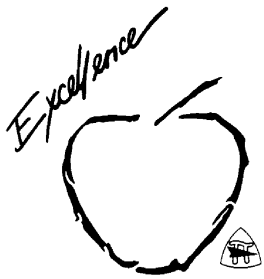
