1. I understand my membership is voluntary. I fully understand that the annual association dues, fees, and assessments required for membership in the four associations are subject to periodic change by the governing bodies of the associations and authorize on a continuing basis the payment of the modified dues unless I revoke my membership in writing with the appropriate local association or I am no longer working with the school district.
2. I understand that I must maintain active and continuous membership to continue to receive membership benefits, legal services, and any other NEA or CEA products.
3. The CEA Active full-time membership dues for teachers, building principals, and college faculty includes \$43 Every Member Option (EMO) for political activities and \$15 Public Relations Assessment for CEA's advertising campaign. The CEA Active full-time membership dues for Education Support Professionals includes \$21.50 EMO and \$7.50 PR Assessment. EMO and the PR Assessment are pro-rated for part-time members. CCEA membership for teachers, mental health and nurses includes \$15.27 for active full time and \$7.64 for active part time Every Local Member Option for political activities to support public education and it is prorated based on membership start date. The CEA and CCEA will refund the EMO and LMO by check if the member notifies CCEA and CEA in writing before December 15 by U.S. mail or email at the CCEA website cceanow.org and the CEA website, coloradoea.org. CCEA and CEA notify all Active members who join after Dec 15 about EMO. Retired, Student, and Reserve members do not pay EMO or the PR Assessment, though they may make contributions to either or both. There is EMO refund information at coloradoea.org. *Providing U.S. Citizen information is voluntary, it is collected in order to refund Every Member Option*
4. The NEA Active membership includes a special assessment set by members through the NEA Representative Assembly to help state affiliates, such as CEA, defeat anti-public education ballot issues and help members in other state affiliates fight the attacks on public sector employees and unions. The special assessment is an obligation for all Active and Student members and is included in the NEA dues.
5. Ethnicity information is optional.
6. Gender information is optional. Current choices for gender are: Female, Male, Transgender Female, Transgender Male, Gender Expansive/Non-Conforming, Other.
7. If you work 59% or less, you will pay half dues. This is determined by your employment contract and by the threshold of 1,440 hours for Educational Support Professionals. If an Active member joins after September 1, the local association must pro-rate the dues by the number of months remaining in the membership year. Retired and Student memberships are not prorated.
8. Dues payments are not deductible as charitable contributions for federal income tax purposes, but (a portion) may be deductible as a miscellaneous itemized deduction.
9. Your information is confidential. Membership is open only to public education employees and students in pre-teaching programs at any public or private college/university.
10. As a new member, you should keep a copy of this form as a record of your contract with CEA-NEA, FRUU, and your Local Association (if applicable).
